5. Delegations, Special Speakers and Public Input

5.1 Merrill Scott

Mr. Scott questioned Council as to why the interim CAO was still at the meetings. The Mayor responded that the salary negotiations with the candidate for CAO were at an impasse.

5.2 Alan MacKinnon - Georgetown Port Incorporated

Tim Mair spoke on behalf of the Georgetown Port Inc and gave his report on the project for which the GPI is seeking a letter of support. The GPI owns the Georgetown wharf and much of the surrounding area and wants to develop the area as they see Three Rivers as having tremendous tourism potential. The proposed tourism shop development is projected to be a \$300-500,000 investment. GPI has also been working on a getting cruise ships to come to Georgetown as well and has invested substantial time and finances toward this cause.

6. Reports

6.1 Development Permit Report

There was no report for this meeting.

6.2 Cardigan water report

Council discussed the Cardigan water report and decided that the report writer should be invited to come to a meeting and explain the report and answer questions. Council discussed some of the options to the water and/or sewer issues that some houses are experiencing. It was decided to get the report writer to come and talk to Council and also to try and get the water sampling reports done at the old dump site to clarify any confusion about possible water contamination from the site. There was also a general feeling that the citizens did not feel that they were being heard and that effort should be made to meet with the residents to hear their concerns and discuss options.

Deputy Mayor Johnston will contact Peter Joostema (report writer) to come and explain the report to Council.

6.3 RCMP Report

S/Sgt. Fitzpatrick gave the November 2018 RCMP Report to Council and answered questions.

7. Requests for Decision

7.1 Georgetown Port Authority letter of support

Council had heard the report from GPI earlier in the meeting and expressed their support for the project. Consensus was given to move this item forward for a decision at the January 14/19 Regular Council Meeting.

7.2 WelcomePEI Guide advertising

Council discussed whether we might cost share the ad with another organization like the GPI, Waterfront Corp or another Town affiliated organization. As time is short and a decision needs to be made to meet printing schedules, consensus was given to move this item forward for a decision at the January 14/19 Regular Council Meeting to purchase a two page ad for \$4,730.

7.3 Montague - Mt. Hamilton Goodwill Games

Council discussed the request and decided it would be prudent to put a donation policy in place before making any more donations. They stated that the proponents of this request could ask to be included in the 2019/20 budget.

7.4 Three Rivers Procedural Bylaw (draft)

CAO Jenkins explained that there are several bylaws that will need to be put in place in the upcoming months, some of which are more crucial than others. His list of most important bylaws included: Procedural Bylaw, Grants & Donations Bylaw and Remuneration Bylaw.
