Councillor Spin requested info on the Dewar's trailer park. The park is privately, and the sewer issues are the owners concern. It was noted that a larger lift pump was put in to address the issue. Councillor Spin said he is also getting complaints of unsightly properties at the trailer park. Councillor Spin was directed to request residents in Lower Montague to write a formal complaint to be sent to the Town office where they could be addressed if there was a bylaw in place.
