WHEREAS there is untapped potential to create critical mass and a stronger presence by strategically combining the strengths of these boards and possibly including other related community-based efforts, and

WHEREAS Three Rivers desires to obtain as much benefit as possible from all its assets, and

WHEREAS Memoranda of Understanding with said boards are outdated and in need of review, and

WHEREAS the boards at different times have requested from Council some indication of mandate and role, and

WHEREAS the Garden of the Gulf Museum and the Kings Playhouse are participants in the groundwork to develop a sustainability study for arts and culture,

THEREFORE BE IT RESOLVED THAT Three Rivers contract the services of Mr. Roy Main to:

- 1. contact the remaining boards (MWDC, Sportsplex and Community Welfare League) that presently run Town facilities, as well the Montague Economic Dev. Corp., and ensure they understand the Town is looking to build for the future by capitalizing on their strengths while helping to address any shortfalls, and that we are looking to move the whole municipality ahead together,
- 2. invite other groups with similar interests to participate in the discussion about structure and planning for the future,
- 3. submit regular activity reports through the CAO to Council, and
- 4. develop alternatives and recommendations for Council.

BE IT RESOLVED the Town of Three Rivers authorizes a consolidation loan for the Montague Water and Sewer Utility, in the amount of \$62,037.43 with CIBC. This is for a two (2) year term amortized over two (2) years at a fixed rate of 2.022%. The loan will be repaid in monthly blended payments of \$2,639.67. This amount will not cause the Montague Water and Sewer Utility to exceed its debt limits as defined in the General Borrowing Bylaw.
