WHEREAS the Minister of Communities indicated in October, 2019, the Province's willingness to entertain a proposal for an alternate solution, in accordance with section 39(3) of the Municipal Government Act, and

WHEREAS the size of the next Council of the Town of Three Rivers was fixed at eight through the Council Size Bylaw in October, 2019, and

WHEREAS the Electoral Boundaries Commission has presented a thoughtful and innovative report which sets out eight wards but departs more from traditional boundaries than is comfortable, therefore

BE IT RESOLVED THAT the report of the Electoral Boundaries Commission is rejected.

WHEREAS the 2019 lease included a clause giving Three Rivers the first option to purchase the property at its Fair Market Value or such lesser amount as the owner may agree to, and

WHEREAS the qualified opinion of Fair Market Value was \$6,000-\$8,000, and

WHEREAS the owner declined two offers to purchase the property for less than the asking price of \$39,000, and

WHEREAS the ball field on this property is an integral part of the Cardigan Ball Complex, and

WHEREAS Three Rivers Minor Ball Association depends upon the capacity of the entire Ball Complex, therefore

BE IT RESOLVED THAT Three Rivers purchase PID 160028 from John Alexander MacDonald for \$39,000, with the funds to come from the Cardigan Reserve Fund.

7.5 Request for Decision 21-01 Queens Road sidewalk north side

WHEREAS the intersection is situated such that landing places on the south side of Queens Road are deficient for safety reasons, and

WHEREAS there is a desire to assist residents of both the Campbellton Street and the Bailey Drive areas to safely enter the sidewalk on the south side of Queens Road, and

WHEREAS a section of sidewalk on the north side of Queens Road between Campbellton and Bailey would enable pedestrian traffic to move more safely to the Princess Drive intersection, and

WHEREAS a flashing crosswalk light could be used more safely at the Princess Drive/Queens Road intersection,

AND WHEREAS timing is right to include this section of sidewalk as part of a tender now being prepared for summer 2021 construction, therefore

BE IT RESOLVED THAT Three Rivers request that the Department of Transportation and Infrastructure include a section of sidewalk between Campbellton and Bailey in its upcoming tender, and that \$22,500 of costs are to come from the Montague Reserve fund.

7.7 Request for Decision 21-04 Heatherdale Community Club

WHEREAS Three Rivers is desirous that the Heatherdale Hall be renovated and used by the community, and

WHEREAS Three Rivers closed the hall it formerly leased due to concerns about public safety, and

WHEREAS Heatherdale Community Club Inc. has been provided with the building inspection report that Three Rivers commissioned, and

WHEREAS there is interest from the Heatherdale community in opening and running the Heatherdale Hall, and

WHEREAS preserving and maintaining the way of life in the rural areas is in the best interest of Three Rivers, and

WHEREAS the Grants Policy of Three Rivers allows Council to approve grants that do not meet all the Guiding Principles and Processes when it is deemed in the best interest of the Town to do so, and

WHEREAS funds are available through the Valleyfield Reserve fund and need not be sought from the operational budget, and

WHEREAS Council wishes to enable the community to open Heatherdale Hall as quickly as possible, therefore

BE IT RESOLVED THAT a grant of up to \$3955 be made available to Heatherdale Community Club Inc. for the purposes of installing an oil tank at Heatherdale Hall, filling the tank with oil, and reconnecting power. The funds will come from the Valleyfield Reserve fund under the following conditions:

- 1. Prior to the provision of any funds to the Club, the Club shall Indemnify the Town of any liability from the Club's actions and shall add the Town as an Additional Insured on the Club's insurance policy, and
- 2. Up to \$3955 including taxes will be granted to Heatherdale Community Club Inc. in the form of reimbursement for invoices for installation of an oil tank at Heatherdale Hall, the purchase of oil, and connecting electricity. Invoices are to be submitted no later than August 8, 2021.
