Sewer Corporation discussed the plans presented from CBCL The cost of the project could be in the vicinity of \$80,000.

Discussions occurred on properties that would be serviced. This will only provide sewer to one property and replace the current line to a property that is not to code. NO other residents would have access. It would not address any issues that could occur along Wood Lane in future. It would not provide a connection the property on the opposite side as it has access already from water Street.

Funding sources would be sought. If it is considered repair and maintenance then Gas tax can not be used. It would mean applying for MSC in the Fall and starting the project after that.

Information will be obtained and a recommendation will be presented for Council meeting in June.
