CANDIDATE NOMINATION INSTRUCTIONS/GENERAL INFORMATION

Nomination period commences September 8, 2021 and closes at 2:00 pm September 17, 2021.

- 1. Complete Form MGA-RE-3 Nomination of Candidate
 - Candidates must be qualified as per the Municipal Government Act (MGA):
 - A person is entitled to run in an election if the person:
 - Is a Canadian citizen;
 - Is at least 18 years of age, or will attain that age on or before election day;
 - The person has been ordinarily resident in the *municipality* for a period of at least six months before election day.
 - Nominations candidates for Three Rivers, Ward 4 Victoria Cross By-Election must have five (5) nominations from qualified electors.
 - A qualified elector:
 - Is a Canadian citizen;
 - Is at least 18 years of age, or will attain that age on or before election day;
 - Has resided in the province for at least the six-month period immediately preceding election day; and
 - Is ordinarily resident in *Three Rivers Ward 4* on election day.

- 2. Return the completed Nomination form to the election office, Greenfield Stormriders Snowmobile Club, 383 Nielson Road, Montague during the following office hours:
 - Wednesdays 4 pm to 7 pm and Fridays, 10 am to 1 pm starting September 8th with additional hours as follows:
 - Nomination day Friday, September 17th, 9 am to 2 pm. Nominations close at 2:00 pm.
