5.1 Request for Decision 22-06 Town Hall Financing

BE IT RESOLVED THAT the Town of Three Rivers rescind Resolution 22-007, which authorized a loan in the amount of \$750,000 with Scotiabank for a five (5) year term, amortized over Twenty-Five (25) years at a rate of 2.74% which would be repaid in monthly blended payments of \$3,456.

BE IT RESOLVED THAT the Town of Three Rivers authorize a loan in the amount of \$750,000 with Bank of Montreal. This amount is for a five (5) year term, amortized over Twenty (20) years at a rate of \$3.38% and will be repaid in monthly blended payments of \$4,299.76. There is a fee of 1% (\$7,500) of the loan request that is to be paid at the time of approval in order to guarantee the quoted interest rate. This fee is refundable back to the Town once the loan is funded. This amount will not exceed its debt limits as defined in the General Borrowing Bylaw.
