

**Town of Three Rivers, PEI**  
**Amendment No. 1 to the**  
**Bylaw to Establish Tax Rate Groups, Bylaw # 2019-05**  
**Bylaw # 2022-01**

**BE IT ENACTED** by the Council of the Town of Three Rivers as follows:

**1. Title**

- 1.1. This bylaw shall be known and cited as the "Tax Rate Groups Bylaw Amendment No. 1."

**2. Authority**

- 2.1. Subsection 8(1) of the *Real Property Tax Act*, RSPEI 1988 c R-5, provides the authority for Council to establish tax rates.
- 2.2. Subsection 160(1) of the *Municipal Government Act* R.S.P.E.I. 1988, Cap. M-12.1., enables Council to set and approve a rate or rates, by resolution, for all real property within the jurisdiction and boundaries of the municipality.
- 2.3. Subsection 160(2) of the *Municipal Government Act* enables Council to establish, by bylaw, separate tax rate groups in the municipality for purposes of raising revenue sufficient to defray projected municipal expenditures.

**3. Application**

- 3.1 This bylaw adds new categories of tax rate groups to be used within the Town of Three Rivers.

**4. General**

- 4.1. The Tax Rate Groups Bylaw 2019-05 is hereby amended by the deletion of Schedule A in its entirety, and replacing it with Schedule A attached.
- 4.2. All other sections of Bylaw 2019-05 remain as is.
- 4.3. The rate or rates of tax that may be approved by Council shall consist only of one commercial rate and one non-commercial rate for each tax group.

**5. Effective Date**

- 5.1. This Tax Rate Groups Bylaw Amendment No. 1, Bylaw# 2022-01, shall be effective as of January 1, 2022.

**First Reading:**

**Second Reading:**


