- the deletion of the paragraph immediately under the heading "Purchase Orders" in Section 5.0 Purchasing Process Thresholds of Procurement Policy (TRF-4), and
- the insertion of the following under the heading "Purchase Orders":

Purchase Orders shall be generated for all purchases of goods and services in excess of \$750.00 (before tax) at the time of purchase duly signed by authorized personnel except when an emergency deems otherwise, in which case a purchase order(s) will be generated immediately following the purchase by duly authorized personnel. The following are exceptions: tendered items, contract services, professional services, and utilities. All other purchases between \$0.00-\$749.99 shall require a signature of an approved department manager on the invoice that will be processed for payment.
