### 6.1 Master services plan update

It was confirmed that the Town has received a draft report from CBCL. CBCL is meeting with staff on Thursday 2nd of June and has asked staff to review the document and provide feedback. CBCL has asked that the draft information is not shared until the meeting has taken place. It was confirmed that CBCL are still taking feedback and that the information will be presented to the committee at a later date, at which point there will be a further opportunity for the committee to make comments.

#### 6.2 **Brudenell Extension**

The committee was updated on the Brudenell Extension. It was confirmed that CBCL are to move forward as the engineers on the project, as per the committee's motion at the March 22, 2022 meeting.

It was noted that the project is waiting on information to be provided in the Master Services Plan, before the project can move into the design phase.

CBCL has issued a letter to L'nuey and who have given approval. The letter has been sent to the federal government and they have confirmed the project is good to go ahead.

The shortage of plastic for pipes and the potential impact on project timescales was briefly discussed.
