7.1 Request for Decision 20-10 Portion of PID 890988

WHEREAS the Town of Georgetown had previously transferred the ownership of PID 890988 to the Georgetown Housing Corp. for its use, and the ownership of the portion of PID 890988 on which housing was not developed reverted to the Town of Georgetown because it was not developed, and

WHEREAS the Province of PEI is now prepared to pursue development on the portion of PID 890988 shown as lot 20-1 on Office of the Chief Surveyor of PEI drawing 19-119-S01, and

WHEREAS said development will consist of ten units of affordable housing, and

WHEREAS the current fair market value of the lot is estimated at \$25,000, and

WHEREAS Lot 20-1 has been declared surplus by the Town of Three Rivers, and

WHEREAS public notice of the intended transaction has been posted as required by the Municipal Government Act and no public input has been received.

THEREFORE BE IT RESOLVED THAT Lot 20-1, a portion of PID 890988 as shown on Office of the Chief Surveyor of PEI drawing 19-119-S01, be divested to the Province for \$1, on the conditions that:

- the Province forfeit its claim and eligibility for the Municipal Affordable Housing Tax Incentive Program on this development, and
- Title to the property will revert to the Town if development does not proceed within two years of conveyance.

7.2 Request for Decision 21-06 Economic Development Recommendation

WHEREAS Council resolved, on March 8, 2021, that a new entity be incorporated to provide economic development services throughout the Town of Three Rivers except for the areas within Three Rivers covered by the GADC, to be known as the Greater Montague Area Development Corporation (GMADC) Board, and

WHEREAS the Discussion Paper received on February 10, 2021, included recommendations about the structure and mandate of the GMADC, and

WHEREAS the Montague Economic Development Corporation held no tangible assets and owed no debt, therefore

BE IT RESOLVED:

- 1. That GMADC be governed by a seven (7) Member Board, with six (6) members being citizens from throughout the area of jurisdiction and initially appointed by Council and subsequently elected at the Annual General Meeting and one (1) member of Council who shall be entitled to hold the office of Director only,
- 2. That the initial mandate of GMADC be as follows:
 - To improve the economy of the Greater Montague area and to enhance the quality of life for its residents
 - To solicit and encourage the establishment and development of new enterprises in and around its area
 - To encourage the expansion of existing enterprises in and around its area
 - To conduct or sponsor projects for the purpose of assisting residents to establish private and/or community enterprises
 - To conduct or sponsor research in the area's resources
 - To conduct or sponsor human resource development measures which will help residents to establish business or obtain jobs
 - To establish physical infrastructure which is strategic to the area's development
 - To encourage the development of tourism opportunities
 - To assist the arts and culture initiatives where possible (results of study will assist here)

- To work in cooperation with the marina operations within the Town for the promotion and expansion of tourism related initiatives, and
- 3. That the Town, working with the MEDC Board, officially dissolve the Montague Economic Development Corporation.

WHEREAS Three Rivers is desirous that the Heatherdale Hall be renovated and used by the community, and

WHEREAS Heatherdale Community Club Inc. has been formed for the purpose of ensuring the viability of the hall into the future, and

WHEREAS preserving and maintaining the way of life in the rural areas is in the best interest of Three Rivers, and

WHEREAS the Grants Policy of Three Rivers allows Council to approve grants that do not meet all the Guiding Principles and Processes when it is deemed in the best interest of the Town to do so, and

WHEREAS investment in the Heatherdale hall is the optimal use of the balance of the Valleyfield Reserve fund, therefore

BE IT RESOLVED THAT the \$11,593.86 remaining in the Valleyfield Reserve fund be granted to Heatherdale Community Club Inc. for the renovation and restoration of the Heatherdale Hall, subject to the following conditions:

- 1. Work is to be contracted by and invoiced to Heatherdale Community Club Inc.
- Funds will be released as contractor's invoices are received for capital improvements made to the hall and grounds as work is completed. Costs pertaining to installation of a well and septic system are eligible.
- 3. This approval is for a maximum amount of \$11,593.86, which is in addition to the \$3955 previously approved.
- 4. The Club shall Indemnify the Town of any liability from the Club's actions and shall add the Town as an Additional Insured on the Club's insurance policy. These measures will remain in place for the duration of the funding agreement.
